## Interpretation

In this Exemption Notice:

- (a) the words 'including', 'includes' and 'include' in conditions mean "including but not limited to", and similar, as appropriate;
- (b) where any word or phrase is given a defined meaning, any other part of speech or other grammatical form of that word or phrase has a corresponding meaning;
- (c) any reference to an Australian or other standard, guideline, or code of practice in this Exemption Notice:
  - (i) if dated, refers to that particular version; and
  - (ii) if not dated, refers to the latest version and therefore may be subject to change over time;
- (d) unless specified otherwise, any reference to a section of an Act refers to that section of the EP Act: and
- (e) unless specified otherwise, all definitions are in accordance with the EP Act.

## **Conditions**

#### **General conditions**

- 1. A supplier for the purpose of this Exemption Notice, is a manufacturer, wholesale or retail company that sells or supplies one or more of the prescribed plastic items listed in Table 1 of this Exemption Notice to a purchaser or consumer, and that manufacturer, wholesale or retail company has a valid:
  - (a) Australian Company Number (ACN) registered with the Australian Securities and Investments Commission (ASIC) to operate within Australia; or
  - (b) Australian Business Number (ABN) registered with the Business Registration Service to operate within Australia.
- 2. A purchaser for the purpose of this Exemption Notice, is a:
  - (a) Wholesale company;
  - (b) Retail company;
  - (c) Registered food or beverage retailer;
  - (d) State Government department;
  - (e) Local Government agency;
  - (f) Incorporated Club or Association;
  - (g) Licensed charity;
  - (h) Incorporated not-for-profit organisation; or
  - (i) School or education facility (early learning, primary, secondary or tertiary institutions):

that purchases any of the prescribed plastic items listed in Table 1 from a manufacturer, wholesale or retail company to sell or supply to a customer or consumer.

#### **Conditions of supply**

3. This Exemption Notice allows suppliers and purchasers of the prescribed plastic items listed in Table 1 of this Exemption Notice, to sell or supply the prescribed plastic items in the specified exempt circumstance and for the corresponding exemption reason only.

## **Supplier requirements**

- 4. A supplier using this Exemption Notice for an exemption under the regulations for a prescribed plastic item listed in Table 1 of this Exemption Notice, must provide each purchaser of the supplied prescribed plastic item(s) with:
  - (a) a copy of the current and valid EN13432 composting or TUV OK compost HOME certification for the prescribed plastic item being supplied; and
  - (b) written evidence that the prescribed plastic item being supplied has a current application before the Australasian Bioplastics Association for certification under the Australian Standards for composting, AS4736:2006 or AS5810:2010, awaiting determination:

in order to sell or supply that prescribed plastic item.

### **Purchaser requirements**

- 5. A purchaser using this Exemption Notice for an exemption under the regulations for a prescribed plastic item listed in Table 1 of this Exemption Notice, must obtain and keep the following records for each prescribed plastic item they have purchased from a supplier:
  - (a) a copy of the current and valid EN13432 composting or TUV OK compost HOME certification for the prescribed plastic item(s) purchased; and
  - (b) written evidence that the prescribed plastic item(s) purchased have a current application before the Australasian Bioplastics Association for certification under the Australian Standards for composting, AS4736:2006 or AS5810:2010, awaiting determination;

in order to sell or supply that prescribed plastic item to a customer or consumer.

#### **Australian Standards certification decision**

- 6. Within 30 business days of the date of determination by the Australasian Bioplastics Association for an application of certification under Australian Standards AS4736:2006 or AS5810:2010 for a prescribed plastic item supplied under this Exemption Notice, the supplier must:
  - (a) notify any purchasers who have received or purchased the prescribed plastic item(s) during the duration of this Exemption Notice and for which the certification application applies, the determination made by the Australasian Bioplastics Association for that certification application; and
  - (b) clearly identify on their website, supply records and customer ordering systems, the outcome of that determination for the prescribed plastic item(s) supplied under this Exemption Notice.
- 7. If an application for certification for a prescribed plastic item made under Australian Standards AS4736:2006 or AS5810:2010 is refused by the Australasian Bioplastics Association the supplier must:
  - (a) immediately cease selling or supplying the prescribed plastic item which has received a refused determination by the Australasian Bioplastics Association; and
  - (b) notify the CEO of the refused certification determination, within 10 business days of the date of determination.

- 8. If an application for certification for a prescribed plastic item made under Australian Standards AS4736:2006 or AS5810:2010 is refused by the Australasian Bioplastics Association, the purchaser:
  - (a) must immediately cease purchasing the prescribed plastic item which has received a refused determination by the Australasian Bioplastics Association, from the supplier; and
  - (b) may continue to supply any prescribed plastic items already purchased from the supplier prior to the date of determination, to a customer or consumer for the remaining duration of this Exemption Notice.

#### **Records**

- 9. A supplier or purchaser using this Exemption Notice for an exemption under the regulations for a prescribed plastic item listed in Table 1 of this Exemption Notice must maintain accurate and auditable books for the prescribed plastic item(s) sold, supplied or purchased under this Exemption Notice. These books must include:
  - (a) a copy of the current and valid EN13432 composting or TUV OK compost HOME certification for each prescribed plastic item; and
  - (b) written evidence that the Exemption Holder has sought certification from the Australasian Bioplastics Association for each prescribed plastic item under the Australian Standards for composting AS4736:2006 or AS5810:2010.
- 10. The books specified under condition 9 must:
  - (a) be legible;
  - (b) if amended, be amended in such a way that the original version(s) and any subsequent amendments remain legible and are capable of retrieval;
  - (c) be retained by the Exemption Holder for the duration of the Exemption Notice; and
  - (d) be available to be produced to an inspector or the CEO as required.

### Non-compliance reporting

- 11. Within 14 business days of becoming aware of any non-compliance with the conditions of this Exemption Notice, a supplier or purchaser using this Exemption Notice for an exemption under the regulations for a prescribed plastic item listed in Table 1 of this Exemption Notice must notify the CEO in writing of that non-compliance and include in that notification the following information:
  - (a) which condition was not complied with;
  - (b) the time and date when the non-compliance occurred;
  - (c) the details and result of any investigation undertaken into the cause of the non-compliance;
  - (d) what action has been taken and the date on which it was taken to prevent the non-compliance occurring again; and
  - (e) what action will be taken and the date by which it will be taken to prevent the non-compliance occurring again.

#### **Revocation or Variation**

12. In accordance with regulation 20(5) of the regulations this exemption notice may be revoked or varied by the CEO or a Delegated Officer at any time by written notice.
